### **Corona virus, hunger and isolation**

Fr Petru Munteanu was calling us at the beginning of the pandemic describing the situation he was confronting every day. The Romanian lockdown found many people unprepared facing sickness, hunger and isolation. "I received many phone calls from parents with young children asking for help. Yesterday, families with 3-4 children came to the church. I gave them everything that I had available." said Father Petru. This happened Neamt County, Săvinești and in its surrounding areas where people who live not on a salary, but on what they earn each day from day labor, were facing hunger. Elderly people isolated in their homes have no food to put on the table. The church was closed. Many tears and suffering" saw Fr Petru who did not waste time and act immediately. He raised awareness about the situation and many people were getting involved. Using the catering services from "Together for Social Solidarity Foundation", Fr Petru was feeding around 200 people daily for almost 5 months. It was not easy to accomplish this without self-sacrifice. Together To Help being at the beginning of its existence, couldn't help as much as it was needed for Fr. Petru's battle with the pandemic crisis. Somebody from here who was battling cancer had a great heart and donated for this cause. Good hearted people from here have donated to this cause. We couldn't do it without you! We are thankful to Fr Petru for being such a great role model and leader of our organization!

## "Steven the Great" Special Vocational School

-packages become gifts from Saint Nicholas



Steven The Great Special Vocational School from Romania is taking care of 118 special needs children ages 14 to 18. Most of them have been abandoned by their families who are unable to care for them. They live in a dorm near their school, receiving food and clothing from state childcare services. The principal, Ms. Liliana Apachitei, and the school staff are their only family.

Fr. Petru Munteanu proposed to get together and help the students improve their quality of life and skills so they will be able to function in the society after the age of 19. In this sense, Together To Help in partnership with the school plan to accomplish 2 important projects: building a greenhouse and planting fruit trees where students will learn agricultural and horticultural skills. The harvested produce will help the school to self-sustain the food necessary for daily meals. Our hope is that the project will happen soon with the help from great hearted donors. During this past summer, I visited the school site and I found out that they have enough land that can be used for agriculture and horticulture. The land is not cultivated yet due to lack of funds.

Meanwhile, with the help of Project 150 in-kind donors, and our financial generous donors, we were able to send six packages of clothing and shoes to Steven the Great Special Vocational School. This donation was offered to the students as a gift from Saint Nicholas on December 6th and made a great impact on the students. There are six more boxes of winter clothing and shoes waiting to be sent to them. We need just few generous donors like you to support the shipping payment to Romania.

The students are still in need of school supplies and other things mentioned on our website.

One hundred and eighteen children with broken hearts are waiting for us to heal their wounds and give them a survival skill in the future!

#### CARES Act Section 2204 amends IRS Code, adding new § 62(a) (22)

The new law allows all taxpayers to take a charitable deduction of up to \$300, even if you do not itemize. If everyone gave "just" \$300, such support would have a huge impact on goals, missions and those the charities serve. The law provides for a universal, above-the-line, deduction of up to \$300 cash made by any taxpayer – whether they itemize or not. This will reduce taxable income for 2020. It makes giving less expensive for donors. This is up to \$300 they won't have to pay taxes on, even if they don't itemize.

#### **Conditions:**

**1.** Gifts must be made in cash.

**2.** Gifts must be made to a public charity, not to a supporting organization, private foundation or donor advised fund.

**3.** Gifts must be made in 2020 (or after; this is not currently limited to just this year), and cannot be carried over from excess contributions made in a prior year.

Gifts are eligible for the above-the line deduction in addition to the standard deduction.

For those who do itemize their deductions, the new law allows for cash contributions to qualified charities to be deducted up to 100% of adjusted gross income for the 2020 calendar year.

#### **Conditions:**

- Gifts must be made in cash to qualify for the 100% of AGI deductibility.
- Gifts must be made to a public charity, not to a supporting organization, private foundation or donor advised fund.
- The increased deduction is not automatic; it must be elected. It is likely the IRS will provide further guidance as the 2020 tax filing deadline approaches.

It's possible the deduction could be disallowed if the donor also makes noncash contributions.

The new law temporarily suspends the requirements for required minimum distributions (RMD) for the 2020 tax year.

Many donors use their RMD to make a gift from their IRA. If you are  $70\frac{1}{2}$  or older, you can still make a gift from your IRA or name a 501(c)(3) charity as a beneficiary.

Donors should see this as an opportunity because there will no longer be a \$100,000 limit on the amount they're allowed to transfer to charity from their IRA. Due to the unlimited charitable deduction allowed for cash gifts this year – even exceeding 100% of AGI – donors can ask IRA holders to sell assets (above the amount of the RMD) and distribute the proceeds to them in cash. They can then donate the cash, realizing an offsetting income tax deduction for the full amount. This may be the only year they can do this. Up until now, donors had to wait to transfer IRA assets in excess of the \$100,000 allowable annually until their death. And those assets could be assessed both income and estate taxes.

## Year-End Campaigns for Holidays

- 1. **Delia**: Save a life of a child on the last day of the year (Delia suffering of Acute Myeloblastic Leukemia)
- 2. *Apopei lonut Catalin* suffering of Lobstein disease or Osteogenesis Imperfecta Type I genetic disease or brittle bone.
- 3. **School supplies** are needed for "Steven the Great" Special Vocational School, from Neamt, Romania.
- 4. **Sewing machines:** "Steven the Great" Special Vocational School needs sewing and embroidery machines and supplies that will help students learn the trade of sewing.
- 5. *Cristian* is a baby boy, 1 year and 9 months old, and can only be fed a special baby formula, Alfamino. The price per box is ~\$50 and the baby needs 3 boxes/week, ~\$600/month. Your help will be appreciated.
- 6. Baby feeding supplies: The baby that needs the feeding supplies can only be fed through a feeding tube that pumps liquid food directly into his stomach. The tubes are one-time use only and he needs about 3 per day. There is only one distributor in Romania, "Nutrient Solutions", and the supplies cost ~\$750/month. When available, the baby's parents buy supplies from eBay at a reduced cost. A minimum donation from each of us will greatly help this family.
- 7. Homeless father and son: We are trying to help a hard working father of a 3<sup>rd</sup> grade child. The child's mother left them. The father works at Jolidon. They had been sleeping in the car for a while, but now the father has started building a small, one room, wooden house. He doesn't have the necessary funds to isolate and finish their new home and the winter is here. The child also needs winter clothes and boots, school supplies and tutoring as he is falling behind in school. Any help will be appreciated.
- 8. *New family*: The couple are in their early twenties and are expecting their first child. They live in Florești, near Cluj-Napoca, Romania, in a rented apartment. The husband was an orphan, raised in an orphanage, and the wife doesn't have her family's support. The husband has a young brother currently in the orphanage whom they would like adopt. They are a wonderful young couple. They will need baby clothes and diapers for their newborn. Your help will be appreciated.
